## COVID - 19 - Operator Classification(s)

Whereas the World Heath Organization has declared COVID-19 a Pandemic on March 11, 2020 and;

Whereas various levels of government continue to put into place measures that are intended to keep the public safe.

Therefore, the parties agree that until such time that the Pandemic is declared over the following process shall be utilized in determining what Driver classification shall operate Class I, Class II and Class III Vehicles.

All drivers shall be able to operate all Vehicles in the DARTS Fleet. All drivers at the date of the signing of this Letter of Understanding shall be "Red Circled".

It is further agreed that the Employer will use B Class Operators to fill existing Class I Vehicles, prior to utilizing G Class Operators to operated Class I Vehicles.

The Employer shall post a list requesting B Class Operators who would be willing to volunteer to operate the Class I Vehicle on any vacant schedules. Those that volunteer shall be awarded the schedule in order of seniority. Once the list is exhausted the employer shall then be able to utilize G Class Operator(s) in order of seniority to Operate Class I Vehicles. It is further agreed that no operator will be forced to operate a vehicle that is outside of their licensing classification.

All drivers hired after the date of signing of the Letter of Understanding shall be B Class Drivers.

This Letter of Understanding will remain in place while the parties are engaged in collective bargaining. Either party may terminate this Letter of Understanding with 30 days' written notice.
